WAIVER & RELEASE FROM LIABILITY

I know that running and walking in a road race is a potentially hazardous activity. I should not enter unless I am medically able and properly trained. I verify to you that I am physically fit and sufficiently trained to participate. I also know that while some police supervision will be provided, there may be traffic on the course. I assume all risks associated with my voluntary participation in this event, including, but not limited to, falls, contact with other participants, the effects of the weather (including extreme heat, extreme cold, snow and ice), traffic, and the conditions on the road with all such risks being known and appreciated by me. Knowing these facts, and in consideration of my accepted entry, I for myself, my heirs, executors, administrators or anyone else who might claim on my behalf, hereby voluntarily release, discharge, waive and relinquish any and all claims, complaints, actions or causes of action ("Claims") against Vision Event Management LLC., Lucky Leprechaun, The City of Wauwatosa, Leff's Lucky Town, Spectrum Group LLC., The MAAC Fund, The State of Wisconsin, Hart Park Director and each of their respective parents, subsidiaries, affiliates, and successor companies, and each of their respective officers, directors, agents, representatives, shareholders and employees, as well as each of their respective successors, representatives and assigns (collectively, the "Released Parties"), including but not limited to those Claims alleging libel, defamation, invasion of privacy or right of publicity, misappropriation, property damage, personal injury or wrongful death ("Losses") arising from or resulting in any manner from my participation in the Event.
